5 Committee - The committee to consist of seven members, with power to add not more than three to their number.
The Chairman to have a casting vote.

6 Membership. - Membership to be open to anyone. The subscription to be not less than one shilling per annum. All applications for membership be handed to secretary who will submit same to committee, the latter reserving to themselves the right to reject any particular applicant if thought necessary.

7 Annual Meeting - "That the annual meeting of club be held sometime during the month of April on a date to be fixed by the committee.
